### Qualification/How to enter

To enter the competition, you must submit your remix(es) of New Days (by Rusher) via email at [marketing@ujam.com](mailto:marketing@ujam.com), before the competition ends. Your submitted remix(es) must meet the following requirements to qualify and be considered as a winner:

- It is a remix of "New Days" by Rusher;
- At least one UJAM plug-in has been used;
- You send your remix to this mail address – [marketing@ujam.com](mailto:marketing@ujam.com); and
- You mentioned which plug-in was used,

You are allowed to enter multiple times, each remix is eligible for one prize.



By entering, you represent and warrant the following with respect to your remix: (1) You are the sole and exclusive creator/owner of the submitted remix (with the exception of any intellectual property or similar rights owned in the original content by Rusher) and such remix was exclusively made for this contest and not for any other purposes; (2) the remix will not infringe on any rights (including, without limitation on intellectual property rights) of any third parties or otherwise breach applicable laws; and (3) any third parties involved in the creation of the remix have given you the appropriate consent and/or licenses to submit the remix for the purposes specified hereunder.

## Judging

Rusher, the artist behind the track "New Days" and his two good friends Jade (the man behind the legendary label "Eatbrain") and V3rb (MC; appearing on many tracks with or by Rusher) will review, evaluate, and select the winning remixes.

Rusher and his friends will judge your remix on audio production (50%); and originality and creativity of your remix (50%).

## Prizes

There will be three winners announced on October 5th, 2022. The first place will be considered for a remix placement on Rusher's "Postcards from the Future Remixes" album (subject to terms and conditions provided by Rusher and applicable rights holders) and will receive "UJAM's Full Bundle". The second place will receive a "UJAM Bundle" of their choice, and the third place a "UJAM Plug-in" of their choice.

If UJAM cannot contact the winning entrant via the email addresses provided when entering the contest, or if the winning entrant does not respond or collect the prize within one month of the announcement, then UJAM reserves the right not to award that prize or to award that prize to a runner-up.



## Changes or Additions

These rules are subject to change, and entrants will be notified on the competition page of any rules or changes to these rules.

## Disqualification

UJAM reserves the right to disqualify any entrant from the contest if it is prohibited in the entrant's jurisdiction or in UJAM's sole discretion, if UJAM reasonably believes that the entrant has attempted to undermine the legitimate operation of the contest. Any non-compliance with these rules may result in the immediate elimination of the entrant from the contest.

## License to Winning Contest/Publicity
